EMPLOYMENT HISTORY

Hokeness Rehabilitation Consulting, LLC, July 1994 to present – Owner/Qualified Rehabilitation Consultant

Registered with the Department of Labor and Industry to provide vocational rehabilitation services adhering to mandated statutes and rules. Consult with injured workers to determine if they are a qualified employee and thus eligible to receive vocational rehabilitation services.
